Summer tax payments may be paid by mail or at the Township office. Summer tax payments are due in our office on or before:

Thursday, September 14, 2023 by 5:00p.m.

\*The office will be open during this time\*
(for tax purposes only)

For your convenience, after tax bills have been issued, monthly payments WILL BE accepted.

# Do you qualify for a tax deferment?

If your gross household income is less than \$40,000 and one of the following:

- ▶ 62 years of age or older; including the unmarried surviving spouse of a person who was 62 years of age or older at the time of death
- Paraplegic or Quadriplegic
- <u>Eligible</u> serviceperson, veteran, widow or widower
- Blind person
- Totally and permanently disabled
- ➤ Eligible agricultural real property

Filing for a deferment by September 14, 2023 allows you to <u>extend your summer tax bill without interest</u> thru February 14, 2024.

A deferment of interest will only apply to the <u>SUMMER</u> portion of your tax bill.

A BURN PERMIT <u>IS REQUIRED</u> FOR ANY TYPE OF OPEN BURNING!!

To avoid the possibility of a false alarm, we recommend you obtain a burn permit even when:

#### "BURNING IN A BURN BARREL"

The <u>preferred</u> method of obtaining a burn permit would be <u>ONLINE</u> at:

This method will assist the safety department in contacting you during those times that burn bans are put in place.

Permits will be valid through Sunday each week, regardless of the day of the week it was issued. A valid email address will be required at time of registration.
